Steve presented the agenda for approval.

Pauline Skinner made a motion to accept the agenda for July 31, 2019 General meeting, seconded by Winston Jibb, carried.

Steve asked if anyone had to declare a Conflict of Interest with the agenda material. There were none. Steve then asked if everyone had read the minutes of last month.

Cheri Bell made a motion to approve the June 26, 2019 minutes as presented, seconded by Bev Louwagie, carried.

<u>Treasurer's Report</u> was presented containing a list of current invoices that require payment totaling \$5,802.26, bank balances, cash, deferred revenue and expenses, as well as the sponsorship collected to date for the fair.

Vicki Williamson made a motion to accept the Treasurer's Report as of July 31, 2019 and pay the outstanding invoices, seconded by David Kemp, carried.

David Kemp made a motion to invest \$25,000 into a TD GIC, seconded by Jean Gloor.

John Miller amended this motion by adding, to invest \$25,000 into a cashable 6 month term GIC, seconded by Jean Gloor, carried.

<u>Dance Committee</u>: Jean Gloor reported they had 73 attend the July dance which made a profit of \$160.50. The 50/50 made \$124, profit of \$62. August 16<sup>th</sup> is the next dance. Jean is still looking for help to make sandwiches at the dances if anyone is interested.

**OAAS:** No report.

**Property Report:** Winston had nothing to report.

#### **Events**

**Rodeo** financial report shows a net profit of \$6,150 after the HST rebate is claimed. (\$2,059 before) Sponsorship is down about \$4,000; gates are up about \$2,000. We spent a lot less. We have not booked Rawhide for next year yet. More discussion is needed before we make a decision to do this a third year.

David Kemp made a motion accept the financial report for the 2019 Mitchell Pro Rodeo, seconded by Winston Jibb, carried.

**Fair:** Janet read Winnie's report in her absence. Sponsorship is favourable; will start "Boosting" on facebook next week; the derby and horse show insurance quote has come in at \$1,800 plus tax.

Leigh Winston made a motion to pay the Insurance Rider for the Derby and Horse Show, seconded by Jeremy Stoskopf, carried.

Cheri said she will ask Dustin Smith to add a P.A system in the announcing booth for the derby. We will charge \$20 per entry car (x 50 cars = \$1000) plus we will add \$2000 in prize money; five heats with a \$600 purse for the winners - \$500 for first, \$100 for second and a plaque for third

Jeremy Stoskopf made a motion to move forward with organizing the Mitchell Fair Derby with a total prize payout of \$3000, seconded by Leigh Winston, carried.
